Lodgement of Nominations

Completed Nomination Forms and Candidate Profile Forms must be received by the Returning Officer, NSW Electoral Commission by no later than 12.00 Noon, Friday 29 August 2014. A candidate may only withdraw his/her nomination in writing so as to be received by the Returning Officer prior to the close of nominations. Any defect in a nomination form or a candidate profile must be rectified by the candidate prior to the close of nominations.

Should more than the required number of nominations be received a draw will be conducted to determine the order of candidates' names on the ballot paper at the NSW Electoral Commission at 2.00pm, Friday 29 August 2014. Candidates or their representatives are invited to witness the draw.

Voting Delegates

To be eligible to vote your P&C Association was requested, via email issued on 24 June 2014, to submit the contact details of your President to the P&C Federation. To be eligible, you have up until 12.00 Noon, Thursday 24 July 2014 to ensure that you have submitted this information.

Voting

If a ballot is necessary, voting material will be posted to all eligible P&C Associations on Tuesday, 9 September 2014. The ballot will close at 12.00 Noon, Thursday 20 November 2014 and the count will be conducted at 1.30pm, Thursday 20 November 2014 at the NSW Electoral Commission. The method of voting for this election is First Past the Post using numbers.
